### **SIOPEN induction chemo-immunotherapy strategy**

- The EC&AB were in complete agreement that SIOPEN needs to progress the development of an induction chemo-immunotherapy strategy as a matter of urgency.
- Need a short safety trial before rapid progression to a randomised phase III trial within HR-NBL2.
- SIOPEN will organise a small working group to develop a high level strategy for submission and discussion with EUSA / Recordati.
